## STATUTE on the International Philosophy Olympiad

### I. General provisions

1.1. The Statute on the International Philosophy Olympiad (hereinafter referred to as the International Olympiad) regulates the organization and holding of the International Olympiad.

1.2. The purpose of the International Olympiad is to promote philosophical knowledge, develop a sustainable interest in classical and contemporary philosophical issues with young people, foster critical thinking skills, and promote ideas of cultural and civilizational diversity. The International Olympiad will also contribute to enhancing of global competitiveness of Russian education, promoting of Russian Language, Russian philosophy and culture on the global level.

1.3. The International Olympiad is held by the Ministry of Science and Higher Education of the Russian Federation, MSU, and IKBFU in 2022.

1.4. Bachelor's, specialist degree, and master's students from Russian and foreign educational institutions are entitled to participate individually and voluntarily in the International Olympiad.

1.5. In-person stage of the International Olympiad will take place in Kaliningrad.

1.6. The themes of the tasks correspond to the following "workshops sections":

- Modern neurophilosophy and issues of AI
- Critical thinking, logic, and argumentation theory
- Ethics in the era of digital reality.
- Philosophical anthropology
- Russia's philosophy and intellectual culture

• Interaction points between philosophy and theology: history and contemporary times.

1.7. No participation fee is charged. Financial Support for the International Olympiad is provided by the organizers.

#### II. The procedure for organising and holding the International Olympiad

2.1. The working languages of the International Olympiad are: Russian, English, Chinese, German and French.

2.2. The procedure of holding the International Olympiad is regulated by the Regulations Act of the International Olympiad.

2.3. The International Olympiad Participants of legal age are under obligation to provide Organizing Committee with the written confirmation of becoming familiar with the Statute and Regulations Act of the International Olympiad, and Consent For Processing Personal Data, including collecting, recording, systemizing, accumulating, storing, extracting, using, transferring (distributing, provisioning, accessing), anonymizing, blocking, removing, destructing as well as and consent for publication of participants' data on the official web site of the International Olympiad.

2.4. The works of the winners and prize-winners of the International Olympiad with authorship attribution will be published on the official website of the International Olympiad with authorship attribution.

# III. Organisational and methodological support for the International Olympiad

3.1. Each year, to provide the organisational and methodological support for the International Olympiad, the Organizing Committee, the Programme Committee, the Methodical Commission, the Jury Panel, and the Appeals Commission are created.

3.2. The Organizing Committee of the International Olympiad includes leading Russian and foreign researchers, representatives of the Ministry of Science and Higher Education of the Russian Federation, and the administration of universities that are holding the International Olympiad.

3.3. The Organizing Committee of the International Olympiad has the following tasks:

- to perform general management and strategic planning functions;

- to determine the exact date when the stages of the International Olympiad will take place

- to form the Programme Committee of the International Olympiad;

- to form the Methodological Commission of the International Olympiad;

- to form the panel of Jury Panel and Appeal Committee of the International Olympiad and determines their authority;

- to hear reports of the Jury Panel of the International Olympiad;

- to approve the decision of the Appeal Committee following the consideration of the participants' appeals;

- to approve the results of the International Olympiad and communicates them to the participants;

- to award winners and prize-winners of the Olympiad with diplomas (certificates).

3.4. The Programme Committee of the International Olympiad has the following tasks:

- to submit proposals on issues related to the improvement of the organization of the International Olympiad to the Organizing Committee;

- In cooperation with the Organizing Committee of the International Olympiad publishes materials, tasks, and results of the International Olympiad on the website.

- ensures the actual execution of the International Olympiad;

- ensures the functioning of the International Olympiad website;

- ensures the functioning of the volunteer corps of the International Olympiad;

- ensures the publication and storage of the Olympiad tasks.

3.5. The Methodical Commission of the International Olympiad has the following tasks:

- develops the tasks for the eliminatory and final stages of the International Olympiad.

- develops criteria and methodologies for evaluation of completed tasks;

- presents proposals on issues related to the improvement of the organization of the International Olympiad to the Organizing Committee;

3.6. Jury of the International Olympiad has the following tasks:

- checks and evaluates completed tasks;

- puts forward propositions about issues related to the improvement of the organization of the International Olympiad to the Organizing Committee;

- presents the list of winners and prize-winners of the International Olympiad to the Organizing Committee for approval.

3.7. Appeal Commission of the International Olympiad has the following tasks:

- considers appeals issued by participants of the International Olympiad

- puts forward propositions about issues related to the results of the considering the appeals to the Organizing Committee;

# IV. Procedures for the submission and consideration of appeals.

4.1. Information on the procedure of admission and consideration of appeals is published on the website of the International Olympiad. Appeals against the results of the first stage of the Olympiad are open for 2 days after the results of the first (online) stage are published in the participants' accounts on the Olympiad information system.

4.2. Participants' appeals are considered by the Appeal Commission of the International Olympiad

4.3. After the Appeal Commission will have considered the appeals and the Organizing Committee will have approved the response to the appeal of the International Olympiad, the participant will receive a response to the e-mail from which the appeal was sent.

4.4. Appeal against the results of the Second stage are open during the day when the preliminary results are published.

4.5. The decision of the Organizing Committee on the appeals is final.
